Invitation to Bid for the PROCUREMENT OF INFRASTRUCTURE PROJECT – DRILLING OF TWO (2) EXPLORATORY/PRODUCTION WELLS FOR CADIZ CITY WATER DISTRICT (Provision of Water Supply to NHA Permanent Housing Program in Yolanda Affected Areas)

1. **Cadiz City Water District**, through the RA No. 10633 (FY 2014 GAA) and R.A. No. 10717 (FY 2016 GAA), intends to apply the sum of **Five Million Two Hundred Five Thousand Two Hundred Fifty Pesos (₱ 5,205,250.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for PROCUREMENT OF INFRASTRUCTURE PROJECT FOR THE DRILLING OF TWO(2) EXPLORATORY /PRODUCTION WELLS FOR CADIZ CITY WATER DISTRICT with Project Identification Number (PPMP No. 2021-01). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. **Cadiz City Water District**, now invites bids for the above Procurement Project. Completion of the Works is required **One Hundred Forty-Five (145) calendar days**. 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from CCWD Bldg., Cadiz City, Negros Occidental and inspect the Bidding Documents at the address given below from **9:00 AM – 4:00 PM**.

A complete set of Bidding Documents may be acquired by interested bidders on **September 23, 2021** from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos Only (Php 10,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees. [Payment shall be received by the BAC secretariat through personal appearance and/or payment through online banking LBP account 0922100926.]
6. **Cadiz City Water District**, will hold a Pre-Bid Conference on **October 1, 2021, 10:00 A.M** at **CCWD Conference Room, CCWD Bldg., Cadiz City, Negros Occidental**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **9:00 A.M. on October 13, 2021**. Late bids shall not be accepted.


8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
